Items Discussed:

Introductions/Celebrations/Community Sharing- had each member introduce themselves and share their individual background. See above. Sheila C. shared that Laura Bales and Xavier Barker were recognized by the coalition for their efforts for the 2109-2020 year. DBHR also recognized Klickitat' Executive Board for their work this past year in hosting an executive board retreat remotely. Principal Justin Draper updated KLASAC concerning Klickitat's plans for reopening school. Principal Lori Smith from Lyle was unable to attend so Barb Mills Lyle School Board Member shared Lyle plans for reopening school. Dawn, from GYM, shared an online recruitment event for the mentoring program on August 26th.

Action Plan and Timelines-Sheila C. shared the two documents. Sheila explained what timelines were not finalized and how we would accomplish those timelines such as Positive Action in Klickitat, Parent Coffee Hours at Lyle and Klickitat, National Night Out, and community surveys, etc. Discussion followed with many interesting ideas as well. Work Groups- Will be looking for members to help with workgroups and their activities this year.

- Media: Will be working on a social media calendar, picking media campaigns to share with coalition, reviewing and helping with PNC, any articles, website, Facebook.
- Evaluation: Will be developing an evaluation plan and assess community awareness of coalitions and events along with perceptions related to substance use.

Summer Commitments-National Night Out was scheduled for August, and has been rescheduled for October. Discussion followed on what ways we could get our message out and across to people in a meaningful way. Has been a large event, how can we keep it going? What and how to support areas with weak internet access? What can we do virtually? The karaoke contest could happen virtually. Discussion for a scavenger hunt was also suggested. B. Mills will contact Tribal Police for their thoughts and ideas for offering karaoke virtually. Discussion about some type of cruise. S. Sutton suggested we apply for funding if available to have on hand. **Key Leader Event-** October event too. Discussion followed on the need to begin planning and be mindful if event needs to be held virtually. S. Crapper will set up meeting with other local coalitions to see how it would/could work. Will not take place until spring.

Community Survey- Discussion about how to best get survey's complete this year. Outreach will continue working on these. Lots of ideas from a raffle to getting on school websites, Facebook, our website, and word of mouth.
